### Article 1. Scope

- 1.1 The First party was established in 1981 with a vision to impart quality technical education but the use of space technology in R&D activities is very much limited at BEC and wish to enhance it with support and collaboration with NESAC. Taking the requirements of the First party, it is proposed to collaborate between the parties in the following areas of mutual benefit:

### Article 3. Entry into effect, modification and termination

Cost for any activity of interest will be worked out specifically for that activity as per the actual under prevailing rules and regulations of both the institutions.
